glaucoma will be stopped but the messages or morale of this story is that for each of us it's just like we use to do for high blood pressure it doesn't give any symptoms, the eye correct, the eye correct until it can't no longer correct and once that happen you will go blind shortly, so please have your glaucouma test done at least once a year, particularly us that getting older people, I mean getting older by forty and up because it will sneak up on you and it can make you blind, it's a simple test you can have it done by an optometrist if you want to, so please have it done, thank you so much for the time, then Eminent Prior Hossie J. Ware said so we need to notified the registrar ok and we have to deal with the other bodies to make sure he is current in those we would like to have one hundred percent right Eminent Prior we would like to have one hundred percent of our people on rolls paid ok are there any other question any other question all those in favor of the motion signify by raising your hand or saying I opposing having the same have none, seeing none motion passed thank you very much, now we are going to move on to the election for the ensuring year of 2022-2023 Knight Registrar how many people that are present that will vote, then Knight Registrar Othello Burton said Jurisdictional Deputy you have 25 somebody dropped 24 now, then Jurisdictional Deputy Donald R. Ware ask de we have on or is Raul on to help us with this voting mechanism, then Knight Raul M. Randle said yes sir, so if you have an opposition we have to do it electronically and you can't count my vote because I'll be running the polls, then Jurisdictional Deputy Donald R. Ware said could you explain to us so all members would have a good understanding how the voting process work, then Knight Raul M.
